THE STATE OF OKLAHOMA TO THE AFORESAID DEFENDANTS: You are hereby notified that The Board of Education of the Town of Bradley of the State of Oklahoma under and by virtue of the laws of the State of Oklahoma in its corporate name and pursuant to the powers granted to it under the statutes and laws

of the State of Oklahoma, has selected a schoolhouse site in the Town of Bradley upon the following described real estate, to-wit:

Lots One (1) to Nine (9) inclusive, and Lots Sixteen (16) to Twenty-four (24) inclusive, in Block "C"; ~~Lot~~ Lot One (1) in Block "B"; Lots Thirteen (13) to Fifteen (15) inclusive in Block "I"; and Lots Ten (10) to Fifteen (15) inclusive in Block "H" in the Town of Bradley, Grady County, Oklahoma, as shown by the official recorded plat thereof,
